IN ADDITION, WE COORDINATE AND SUPPORT VOLUNTEER CLINICIAN EFFORTS TO SET UP TEMPORARY RURAL CLINICS. THE ORGANIZATION ALSO OPENED A SCHOOL FOR PRESCHOOL THROUGH FIRST GRADE FOR CAMANCHAJ CHILDREN.
